NO RETURNS OR CANCELLATIONS ON CUSTOM, MODIFIED FIXTURES OR TRACK PRODUCTS. NO RETURNS 30 DAYS AFTER SHIPMENT TO CUSTOMER. ALL CANCELLATIONS MUST BE RECEIVED BY THE FACTORY IN WRITING. ALL RETURNS MUST BE ACCOMPANIED BY A FACTORY AUHTORIZED RETURN GOODS AUTHORIZATION NUMBER OR THEY WILL NOT BE ACCEPTED. ALL FREIGHT COSTS FOR RETURNED ITEMS, INCLUDING ORIGINAL DELIVERY, MUST BE PREPAID BY THE PARTY RETURNING THE PRODUCTS.
